

**Annual Governance Statement for the Governing Body of
Solway Community School
September 2017**

In accordance with the Government's requirement for all governing bodies, the 3 core strategic functions of the Solway Community School Governing Body are:

- 1. Ensuring clarity of vision, ethos and strategic direction;**
- 2. Holding the Headteacher to account for the educational performance of the school and its pupils;**
- 3. Overseeing the financial performance of the school and making sure its money is well spent.**

Governance arrangements

The Governing Body of Solway Community School is made up of 14 Governors: 5 Parent Governors, 1 LA Governor, 1 staff Governor, 1 Headteacher and 6 co-opted Governors.

The full Governing Body meets once a month. Some of the meetings are virtual (i.e. via email, not face to face) but face to face meetings happen at least once every two months.

We also have committees that meet if required to consider pupil discipline and staffing matters.

Each Governor is also aligned to one of the three faculties (Maths and Science, Technical, Creative & Vocational, and Language and Humanities) depending on their expertise and interests, and hold regular meetings with faculties to review progress and activities.

The work that we have done on our committees and in the governing body

The Governing Body has had a busy year supporting our Headteacher to further improve the school and ensure that student progress continues to be rapid and sustained. They supported the launch of the collaboration with Beacon Hill, and were delighted to appoint Mr Hailwood as Deputy Headteacher when Mrs Schafer was appointed as Executive Headteacher of both Solway and Beacon Hill Schools.

November 2016 saw a visit from Ofsted, and while we were again judged as 'Requires Improvement', the detail showed that we have made significant progress, particularly in Effectiveness of Leadership and Management (now 'Good') and in Personal Development, Behaviour and Welfare ('Good') and the number of actions required significant reduced.

The Governing Body have dealt with budgets, revenue and capital

	<p>spends for this year and have ensured that our three year budget is on track and is healthy as well as supporting the Executive Headteacher in improving the performance of our staff. They have supported the recruitment of several new members of staff to replace leavers and as at September 2017 were fully staffed with appropriately qualified teachers.</p> <p>Minutes of Governing Body and Committee meetings are public documents – they are available on request from the Clerk to the Governors.</p>
